Role of Maryland State Task Force

As the Task Force, we want to help you achieve the continuing education that is required for the license renewal. The Task Force does not make any decisions for the licensing board. However, we do assist Maryland Music Therapists in the licensing process, so that you are able to achieve and maintain your state license in order to practice.

Role of Board

The Board of Examiners for Audiologists, Hearing Aid Dispensers, Speech-Language Pathologists, and Music Therapists makes ALL the decisions regarding the license. License renewal links and guidelines will be emailed and posted by the board on their <u>website</u> in December 2025-January 2026.

Important Information

Regulations are printed on the <u>Maryland Register</u>. To find the regulations for music therapy, scroll down to "Propose Action," title 10, subtitle 41, section 5, about two-thirds of the way down.

The Maryland Music Therapy license is renewed every 2 years. Everyone renews at the same time regardless of when you received the license. Continuing education requirements are specified by the regulations. Upon renewal, you will need to submit a record of at least 40 hours of continuing education units (CEUs) from CBMT-approved programs, or the "Prorated CEU Requirements for the 2026 Renewal" depending on when you received the license within the last 2 years. The following 7 CEUs must be included in the total 40 hours:

- 1 CEU Cultural Competency
- 1 CEU Ethics
- 2 CEUs Supervision
- 1 CEU Billing
- 1 CEU Interdisciplinary Collaboration

• 1 time - <u>Implicit bias</u> ("This is a one-time training." If you completed it already at any point of having the license, you have completed the requirement.)

Please note, CEU and CMTE (continuing music therapy education) are interchangeable here. Most other professions use "CEU."

If you are chosen for the **random audit**, the documentation outlined in the <u>Recertification Manual</u> and on the <u>Recertification Chart</u> would be required at that time.

Basic Guidelines for Board Recertification

Recertification credits must be...

- Related to the **Board Certification Domains**
- A minimum of 50 minutes per credit
- Completed within the last 2 years of your current cycle

Finding Courses

CEU/CMTE Checklist

You need 40 CEU/CMTEs for license renewal. Out of those 40 credits, 7 of them must include: 1 for cultural competency, 1 for ethics, 2 for supervision, 1 for billing, and 1 for interdisciplinary collaboration. The 1 CEU for implicit bias credit only needs to be completed one time during the first cycle of your license.
